Off-Label Drug Use

From the FDA perspective, once the FDA approves a drug, healthcare providers generally may prescribe the drug for an unapproved use ("off-label") when they judge that it is medically appropriate for their patient.

This is common. Some examples of off label use are:

- Used for a disease or medical condition that it is not approved to treat, such as when a chemotherapy is approved to treat one type of cancer, but healthcare providers use it to treat a different type of cancer.
- Given in a different way, such as when a drug is approved as a capsule, but it is given instead in an oral solution.
- Given in a different dose, such as when a drug is approved at a dose of one tablet every day, but a patient is told by their healthcare provider to take two tablets every day.

Why are FDA-approved drugs such as Ivermectin and Hydroxychloroquine not allowed to be used off-label to treat the virus known as "Covid"? Please see below.

Ivermectin & the Nobel Prize

In 2015, the Nobel Committee for Physiology or Medicine, in its only award for treatments of infectious diseases since six decades prior, honored the discovery of Ivermectin (IVM), a multifaceted drug deployed against some of the world's most devastating tropical diseases. Since March 2020, when IVM was first used against a new global scourge, COVID-19, more than 20 randomized clinical trials (RCTs) have tracked such inpatient and outpatient treatments. Six of seven meta-analyses of IVM treatment RCTs reporting in 2021 found notable reductions in COVID-19 fatalities, with a mean 31% relative risk of mortality vs. controls. During mass IVM treatments in Peru, excess deaths fell by a mean of 74% over 30 days in its ten states with the most extensive treatments. Reductions in deaths correlated with the extent of IVM distributions in all 25 states with $p < 0.002$. Sharp reductions in morbidity using IVM were also observed in two animal models, of SARS-CoV-2 and a related betacoronavirus. <https://pubmed.ncbi.nlm.nih.gov/34466270/>

Why is Ivermectin not allowed? Ivermectin works against COVID-19 by multiple mechanisms. The drug received a Nobel Prize for human treatment, not veterinary. It is on the WHO list of essential medicines. Its use as an effective early outpatient treatment for the virus known as "Covid" would have blocked the ability of pharma to get emergency use authorization for their vaccines. Could it be that Pharma did not want use of Ivermectin which is inexpensive since they are able to make billions in revenue for their vaccines? For 2021, Pfizer reported over \$30 billion and Moderna over \$17 billion from their COVID vaccines.

Remdesivir, Ebola and Pfizer, Trovan Trials

Remdesivir & The Ebola Trials

On April 29, 2020 White House health advisor Dr. Anthony Fauci said that testing on Gilead Sciences' antiviral drug Remdesivir showed "quite good news" and sets a new standard of care for Covid-19.

Remdesivir has a less than stellar track record. In a 2019 study of its use against the Ebola virus, it was dropped. There were four drugs used in the Ebola trial. In an interim analysis, Remdesivir was excluded from further study because of a 53.1% mortality rate compared to ~35% for two other drugs.

Another study was a March 2020 study of a very small sample size, 53 patients, with COVID, conducted and funded by Gilead Sciences, the pharmaceutical company producing Remdesivir. An additional 8 patients were excluded for missing data. Of 53 in the trial, 60% had adverse events with 23% developing severe adverse events including multi-organ system dysfunction, septic shock, or acute kidney injury. Mortality was 13%, but the patients only had a median follow up of 18 days. Only 47% of the patients had improved to be discharged at the completion of the study. The authors note that this is a "preliminary" study. Subsequent studies of Remdesivir have NOT shown a mortality benefit. <https://www-nejm-org.wvu.idm.oclc.org/doi/pdf/10.1056/NEJMoa2007016?articleTools=true>

Remdesivir has 2 major drug interactions and 360 moderate drug interactions and may cause kidney and liver dysfunction.

Pfizer & The Trovan Trials

"Pfizer accused of testing new drug without ethical approval"

In 1996 Pfizer sent a team to Kano in the north of Nigeria during an epidemic of meningococcal meningitis. To test the efficacy of its new antibiotic trovafloxacin (Trovan) they carried out an open label trial in 200 children, half of whom were given trovafloxacin and half the gold standard treatment for meningitis, ceftriaxone. *The Washington Post* reported that Nigerian patients were not warned that animal studies had shown that drugs similar to trovafloxacin may cause joint damage, whereas US patients were told of the research in a subsequent trovafloxacin trial. The drug's license was withdrawn in Europe because of liver toxicity and some deaths.

The investigation has generated a lot of publicity in the Nigerian press. The newspaper Vanguard said: "The government has a duty to tell us whether our children were used as guinea pigs and, if so, who committed such criminality and who is liable."

A class action suit filed on behalf of the children's families in a federal court in New York alleges that Pfizer did not inform families that trovafloxacin was an experimental treatment and that it failed to obtain informed consent (BMJ 2001;323:592). Court documents filed by the plaintiffs said that "most tragically, Pfizer purposely ... low-dosed the control drug" and did not tell families that free, approved treatment was available at the same hospital from Médecins Sans Frontières.
